INDONESIA

*(Aluminum Foil)*

The following communication, dated 6 November 2019, is being circulated at the request of the Delegation of Indonesia.

---

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia hereby notifies the issuance of Minister of Finance's Regulation Number 153/PMK.010/2019 dated 24 October 2019, promulgated in the Official Gazette of the Republic of Indonesia Number 1322 on 24 October 2019 regarding the imposition of a safeguard measure on the importation of Aluminium Foil, for a period of 2 (two) years started on 6 November 2019.

**1 GENERAL BACKGROUND**

On 5 February 2019 The Republic of Indonesia notified the findings of safeguard investigation in which it was concluded that there was an evidence that the increased of volume of imports have caused serious injury to the domestic industry concerned in this investigation (G/SG/N/8/IDN/21-G/SG/N/10/IDN/21).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia the imposition of a safeguard measure on the importation of the subject goods.

**2 DESCRIPTION OF THE SUBJECT GOODS**

The description of the subject goods are as follows:

"Aluminium foil (not printed or not backed with paper, paperboard, plastics or similar backing materials) with a thickness not exceeding 0.2 mm, rolled but not further worked, with aluminum content more than or equal to 97.5% according to its weight", under Harmonized System (HS.) Code: Ex. 7607.11.00".

**3 DESCRIPTION OF THE MEASURE**

- a. The Government of the Republic of Indonesia has decided to impose the following safeguard duty:

**TIMETABLE OF THE SAFEGUARD DUTY**

<b>Period</b>	<b>Safeguard Duty</b>
First year (7 November 2019 – 6 November 2020)	6%
Second year (7 November 2020 – 6 November 2021)	4%
